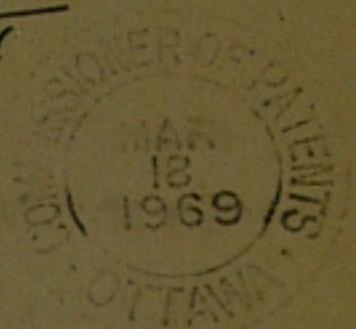

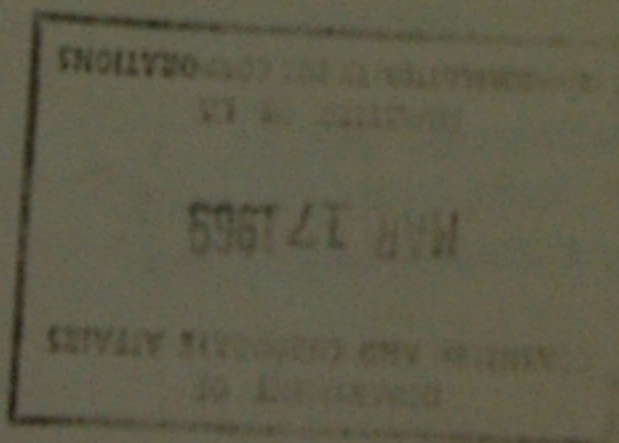
WE WISH TO MAKE SEVERAL GENERAL OBSERVATIONS ON CANDELS REPORT ON ABOVE MTG IN WHICH WE PARTICIPATED. FIRST IN ADDITION TO RECOMMENDATIONS INCLUDED IN REPORT WITH WHICH WE FULLY CONCUR WE WOULD ENCOURAGE CDN INITIATIVE IN THIS FIELD AND SUGGEST THAT ONCE CDN POSITION IS REACHED CONSULTATION TAKE PLACE WITH LIKE-MINDED MEMBERS OF JOINT STUDY GROUP PRIOR TO WSHDC MTG WITH VIEW TO PROMOTING VIABLE SOLUTION TO INNATL COPYRIGHT PROBLEMS.


2. WE WOULD DRAW YOUR ATTN IN PARTICULAR TO THE PROBLEM OF DEFINING QUOTE DEVELOPING COUNTRY UNQUOTE WHICH IS RAISED IN PARAS(3)(1) OF FEB14 REPORT. THERE IS IN FACT NO/NO AGREED DEFINITION IN COMMON USAGE BY ANY MULTILATERAL AGENCY. IN UNCTAD FOR INSTANCE ON QUESTION OF GENERAL SCHEME OF PREFERENCES DEVELOPED COUNTRIES HAVE INDICATED FORMULA WHEREBY ANY COUNTRY NOMINATING THEMSELVES AS LDC WOULD BE CONSIDERED ELIGIBLE TO PARTICIPATE IN SCHEME. LDCS ON OTHER HAND ARE CONTINUING TO ARGUE IN FAVOUR OF ESTABLISHING SPECIFIC AND AGREED LIST. DIFFICULTIES INVOLVED ARE SUCH HOWEVER THAT IT IS UNLIKELY TO PROVE POSSIBLE TO ARRIVE AT CLEAR OR PRECISE DEFINITION IN THIS OR IN ANY OTHER CONTEXT.
