FUTURE RELATIONS BETWEEN WIPO AND UN WAS DISCUSSED BY COORDINATION  
CITEE BASED ON REPORT BY MARTIN HILL, DOCU PREPARED BY SECRETARIAT  
AND DRAFT BRAZILIAN RESLN.

2. BRAZILIAN RESLN REQUESTS DIR GEN TO EXPLORE POSSIBILITY  
OF WIPO ENTERING INTO SPECIALIZED AGENCY RELATIONSHIPS UNDER  
ARTICLES 57 AND 63 OF UN CHARTER.

3. MOST DELS INDICATED THEIR CONCERN OVER PRESENT STATUS OF  
RELATIONSHIP UNDER EXISTING AGREEMENT AS IT FAILS TO FULLY  
PERMIT WIPO TO FULFIL ITS AIMS. LDCS WITH SUPPORT OF SOCIALIST REPS  
FAVOURED FULL SPECIALIZED AGENCY STATUS AND FAST CONCLUSION OF  
SUCH AN AGREEMENT. IT WAS OF INTEREST THAT SWEDEN AND FINLAND  
JOINTED ARGENTINA, MEXICO AND SENEGAL IN CO-SPONSORING BRAZILIAN  
RESLN. WESTERN DELS ALTHOUGH SUPPORTING CONTINUING STUDIES  
OF THIS QUESTION PREFERRED TO SEE BROADER BASE OF EXAM  
WITHOUT COMMITMENT TO FURTHER ACTION.

4. IN ACCORDANCE WITH INSTRUCTIONS CANDEL INDICATED SUPPORT FOR  
FURTHER EXPLORATION OF ESTABLISHING SOME FORM OF RELATIONSHIP WITH  
UN SYSTEM BUT THAT WE COULD NOT/NOT AT THIS STAGE ENDORSE ANY

PROPOSAL WHICH COULD BE INTERPRETED AS GIVING APPROVAL IN PRINCIPLE TO SUCH TRANSFORMATION. WE THEREFORE STATED THAT WE WOULD ABSTAIN ON ANY FRAGMENTARY VOTE OF OP PARAS 1 AND 2 BECAUSE OF NARROWING SCOPE OF PROVISIONS BUT IN VIEW OF BREADTH OF APPLICATION OF REMAINING OP PARAS WE COULD SUPPORT RESLN AS WHOLE.

5. IN ORDER TO OVERCOME STALEMATE REACHED IN PROTRACTED DEBATE AND WITH WISH TO AVOID EMBARRASSING NOTE WHICH MIGHT HAVE STRENGTHENED HAND OF RESLN SPONSORS CANDEL TOOK INITIATIVE TO REACH COMPROMISE SOLUTION. RESULT WAS THAT RECORD WOULD REFLECT THAT QUOTE COORDINATION CTTEE ADOPTED THE RESLN WITHOUT OPPOSITION AND AS FAR AS THE DELS ARE CONCERNED WHICH MADE RESERVATIONS, SUBJ TO THEIR RESPECTIVE RESERVATIONS AS RECORDED IN THIS REPORT UNQUOTE.
