COUNCIL ADOPTED AGENDA AND ORG OF WORK AS OUTLINED IN E/L 1550/REV1 EXCEPT THAT ITEM 8 ON AGENDA FOR RESUMED SESSION (NGOS) WILL BE TAKEN UP AT THIS SESSION AND ITEM 13 (EXPORT CREDITS) HAS BEEN REFERRED TO UNCTAD FOR PRELIMINARY CONSIDERATION.

2. ITEM 18: WIPO BEING TRANSFORMED TO SPECIALIZED AGENCY STATUS WILL BE DISCUSSED AT ECOSOC 55 AND CTTEE MAY BE FORMED TO EXAMINE AGREEMENT. IN LIGHT OF OTT DISCUSSIONS MARTIN/BUICK WE ASSUME THAT HAVING MADE OUR CASE AND LOST IT IN WIPO ITSELF WE SHOULD NO/NO LONGER OPPOSE IN ECOSOC. UNLESS WE RECEIVE INSTRUCTIONS TO CONTRARY WE WILL NOT/NOT OPPOSE WIPO BECOMING SPECIALIZED AGENCY NOR/NOR SEEK MEMBERSHIP ON CTTEE.

3. ITEM 24 (COLONIALISM): CONSULTATIONS CALLED FOR IN UNGA RESLN 2980 (XXVII) WILL BE INITIATED BY CHAIRMAN OF COORD CTTEE WITH CHAIRMAN CTTEE OF 24.

5. SINCE DICTATING PARA2 ABOVE OUR VIEWS ON WIPO STATUS HAVE BEEN SOLICITED BY SOVIET DGL, WHICH ITSELF APPEARS NEGATIVE ON TRANSFORMATION TO SPECIALIZED AGENCY STATUS. WE RESPONDED ALONG LINES IN PARA2 ABOVE AND WILL MAINTAIN THIS POSN UNLESS WE HEAR FROM YOU TO CONTRARY OR A SOVIET INITIATIVE VS SP AGENCY STATUS GATHERS MOMENTUM.
