MEMORANDUM FOR THE MINISTER Diplomatic Conference to Adopt an International Convention on the Protection of Phonograms, Geneva, October 18-29, 1971 The Department of Consumer and Corporate Affairs has submitted to this Department for comment the attached draft memorandum on Canadian participation in the above conference which, it is proposed, you and Mr. Basford should submit jointly to Cabinet. I am in general agreement with the line taken in the draft as regards the composition of the Canadian delegation and the position which it should adopt at the conference. I am concerned, however, at recommendation 11.(c) of the draft in which it is proposed that two private sector organizations be invited to nominate advisers to the delegation, providing that these organizations bear the expense of their representatives' participation. You will recall that in the case of the conference to revise international copyright arrangements which was held in Paris last month, as a result of Mr. Basford's concern, it was agreed not to send any non-governmental representatives at governmental expense. You will also recall the difficulties to which this policy gave rise with regard to the attendance at this conference of representatives of the Canadian Copyright Institute and the Société Canadienne-Française de Protection du Droit d'Auteur. I believe that to adopt this position in regard to all international intergovernmental conferences would be most undesirable and would require a fundamental change in the composition of Canadian delegations to various United Nations and other international conferences. For the diplomatic conference on phonograms, I think that if it is deemed desirable to invite the two private organizations in question to nominate advisers to the delegation, then the government should be prepared to bear the cost of their participation. accordingly I propose that recommendation 11(c) be altered so that it would read:

"That the Minister of Consumer and Corporate Affairs and the Secretary of State for External Affairs be authorized to invite the two private sector organizations which have a genuine interest in the conference, namely the Canadian Record Manufacturers Association and the Fédération des Auteurs et des Artistes du Canada, to nominate one representative each as advisers to the delegation, the expenses of such advisers to be borne by the Department of External Affairs from its International Conferences vote."

I would also propose one further recommendation be included in the draft Memorandum for Cabinet and a very minor revision be made to the Instructions. To accord with subparagraph 2 of the Instructions, an additional recommendation (f) should read, "that authority be obtained from the Governor General-in-Council, for the head of delegation or deputy head of delegation, to sign, subject to ratification, the Treaty adopted at the Conference, provided the text is consistent with the Instructions contained in Appendix A". In subparagraph 2 of the Instructions I would propose that the words "and that signing does not mean or imply accession" be deleted and the words "subject to ratification" be added after "text" in the first line.

Finally you will note that the draft Memorandum under the heading, "Federal-Provincial Relations Considerations" states that "it appears there is no need to involve provincial authorities in this Conference." Although copyright is a matter which falls within the exclusive jurisdiction of the federal government under the BNA Act, you may be aware that the Province of Quebec has on a previous occasion expressed an interest in Canada's international activities in this field because of the
